The Manager believes that XRP, as one of the oldest and well-known digital assets and 4th largest by market capitalization, has unlocked significant growth potential with the evolution of its XRP Ledger, which aims to introduce smart contract functionality to enable a myriad of other use cases not previously possible on its blockchain.

#### Why XRP?

XRP is the native digital asset of the XRP Ledger (XRPL), an open-source blockchain designed for high-speed, low-cost cross-border payments. Unlike many blockchains that struggle with scalability and transaction costs, the XRPL consistently settles transactions in 3–5 seconds with fees often less than a fraction of a cent. With a strong focus on real-world utility and institutional partnerships and adoption, the XRPL stands out from other smart-contract enabled blockchains. Recent regulatory and institutional developments have propelled the technology to solve for use cases like global remittances, liquidity management, and other real-world use cases. Ripple labs, the company that created the XRPL network, believes that XRPL's advantages may allow it to one day replace the SWIFT network as the world's dominant payments system.

#### **XRP** Price



Since January 2015, the price of XRP, the native token of the XRP Ledger, has grown from just \$0.02 to over \$2.19 today.

This represents a return of over 10,800%, making XRP among the best performing digital assets over the past decade.
